FAQ on Virtual Certificate Course on UAE VAT

Q1. What will be duration of this Virtual Certificate Course?

Ans. The Virtual Certificate Course will be of 5 days of 4 hrs (20 hours i.e. 4 hours per day).

Q2. Whether a non-CA can participate in Virtual Certificate course on UAE VAT?

Ans. No, the Virtual Certificate Course on UAE VAT is for Chartered Accountants only i.e Member of the Institute only.

Q3. Can a CA Final pass student, who doesn't have the membership number register for the course?

Ans. No

Q4. What is the course fee for the Virtual Certificate Course on UAE VAT?

Ans. The course fee for Virtual Certificate Course is USD 110

Q5. What is the maximum batch size of virtual Certificate Course on

UAE VAT?

Ans. The maximum batch size of virtual Certificate Course on UAE VAT is 200 participants. After completing of the batch size, participants need to wait for other batch to get them registered.

Q6. Is there any offline mode of payment available for registration to Virtual Certificate Course on UAE VAT?

Ans. No, there is no facility available for offline payment for registration; member has to pay online for registration.

Q7. If a member registered for UAE VAT Virtual Certificate Course and paid online but the status of payment showing incomplete or didn't receive confirmation mail. What action required in this case?

Ans. You need to write us at <u>gst@icai.in</u> wherein you should mention your

name, membership no., screen shot and payment details, status will be updated.

Q8. Any Background Material on UAE VAT will be provided?

Ans. The participants can download soft copy from <u>https://idtc.icai.org/publications.php</u>. No hard copy will be made available to participant.

Q9. Will it be compulsory to provide faculty feedback?

Ans. Yes, Faculty feedback needs to be submitted by the participant compulsorily since it would serve as a purpose of attendance.

Q10. Will it be compulsory to submit Daily MCQ Test (5 MCQ) before next class?

Ans. Yes, assessment of each day needs to be submitted before the next class or till the date it remains active at the portal.

Q11. Whether recording of the sessions will be available?

Ans. Yes, recording of all the sessions for viewing purposes will be made available after the completion of the course and will continue to be available for 1 month from the end of the course. However, due to technical glitches, it may not be available for some of the session, for which recording of other batch may be provided of the respective session. Recording would not be available for download purposes.

Q12. Whether CPE hours granted would be structured or unstructured?

Ans. 15 Structured CPE hours will be granted after completion of online session for Virtual Certificate Course (on the basis of attendance) and 5 Structured CPE hours would be granted on passing the main Assessment Test of the Course.

Q13. When will the Assessment Test for Virtual Certificate Couse be held?

Ans. Assessment Test for Virtual Certificate Couse will be held online after completion of the course together for some batches and the details of which will be intimated separately at registered email id. Q14. When will the faculty details of Virtual Course be shared with the participants?
